The bridge on Richfield Dr is not bad but does need some work. Dave is going to have to work with the county about getting some pricing for repairs. Keith Albright will look at it to fix/replace posts, etc. Some programs that could be available are 90/10.

Digging from the fiber optic line caused some issues in the ditch for a resident so needs to get repaired. Discussion was had about setting up a bond for the spring.

Ader Lane, north of Eisenhower, needs some work. Probably will have to cut it out and patch it. Dave will have Randy from the county come look at it.

Discussion was also had about rock/sod around culverts in ditch at a residence on S. Washington which has been addressed in the past. We have many properties in the township like this.

Building Maintenance

Main doors should get new sweeps on them to prevent drafts from coming in. Chris will look at it. The refrigerator in the Fire Department is not working properly. Will look into getting a new one.

Ambulance Contract
